

**Ordinance No. 2020-01**

**AN ORDINANCE AUTHORIZING SPECIAL WASTE PICKUP OR SUPPLEMENTAL SERVICES  
AND AUTHORIZING CERTAIN BYLAWS**

**WHEREAS**, the Campton Township Solid Waste Disposal District (“the District”) is a duly organized Solid Waste District under the Solid Waste Disposal Act, 70 ILCS 3105, *et. seq.*, and,

**WHEREAS**, the Trustees of the District have determined that this ordinance is necessary and advantageous and support the public health, welfare, safety and morals of the public and have authorized the same by a majority vote;

**NOW, THEREFORE, BE IT ORDAINED** by the Trustees of the District:

**SECTION ONE: SPECIAL WASTE PICKUP OR SUPPLEMENTAL SERVICES AUTHORIZED:**

1. The President of the District (or any designee thereof) is authorized and directed to utilize any provisions of the then-current solid waste franchise agreement (“Agreement”) in place in the District to order and provide for any special waste collections, cleanups, or other supplemental services authorized under the Agreement, without requirement of prior approval from the Trustees. Any costs incurred for such supplemental services shall be borne by the property receiving the services and shall be a charge against such property that shall be collectible by the District or the solid waste hauler, based upon the terms of the Agreement. In addition, such costs shall be a lien against the benefitting property and its owner(s). The charges recoverable shall include the base charges, any interest or late fees, any costs of collection, attorneys fees or court costs, and statutory interest permitted by law.

2. In addition, the President or designee is authorized to incur charges for the benefit of the District in an amount not to exceed the greater of: a) the budgeted funds available to the District; or, b) the sum of one-thousand five-hundred dollars (\$1,500.00), whichever is less, without requirement of competitive bidding or prior approval by the Trustees.

**SECTION TWO: BYLAWS AUTHORIZED**

The Trustees approve and ratify the now-current provisions of bylaws adopted by the District. Further, the Trustees are authorized to approve and implement any future amendments to the bylaws of the District by majority vote at a public meeting of the District, and such amendments shall take effect after their approval. A copy of the then-current bylaws shall be maintained on the District’s website.

**SECTION THREE: GENERAL PROVISIONS**

**REPEALER:** All ordinances or portions thereof in conflict with this ordinance are hereby repealed, amended to be consistent with this requirement, or superseded by this requirement.

**SEVERABILITY:** Should any provision of this Ordinance be declared invalid by a court of


competent jurisdiction, the remaining provisions will remain in full force and effect the same as if the invalid provision had not been a part of this Ordinance.

EFFECTIVENESS: This Ordinance is approved by the District pursuant to its authority under 70 ILCS 3105/17(b). This Ordinance shall be published at least once a week for two consecutive weeks after its approval, in a newspaper of general circulation in the District. This Ordinance shall take effect on the tenth day after its second publication.
