**Amendment 2020.5**

**Agreement for Solid Waste Disposal Services**

Pursuant to §10.15(c) of the Agreement for Solid Waste Disposal Services [Agreement] by and between Campton Township Solid Waste Disposal District [District] and Lakeshore Recycling Systems, LLC [Contractor], dated April 1, 2020, the District hereby requests the "Cart exchange fee", as stated in §XI. Exhibit G and referencing §II 2.2(h) of the Request for Proposal, be amended with the following language to clarify what this fee includes, the conditions under which this fee may or may not be charged, and when residents may or may not be charged for the replacement cost of a cart(s):

Lakeshore Recycling Systems, Inc. may charge a \$30 Cart Service Fee for providing cart delivery, exchange, or removal services to residential customers. This fee shall provide for the delivery of up to two carts and for the removal of up to two carts each time LRS provides cart service to a residence. Delivery, exchange, or removal of more than two carts will incur an additional fee of \$30 per cart. Additional restrictions may apply to the type or number of cart(s) that may be delivered, exchanged, or removed based upon the gallon size of the waste cart to which the residence is currently subscribed. The Cart Service Fee may or may not be charged, as indicated below, for each of the following conditions:

1. deliver TR<sup>(a)</sup>, REC<sup>(a)</sup>, or YW<sup>(a)</sup> carts to a new account (move-in) – **NO**<sup>(b)</sup>
2. deliver YW cart to a new account (non-move-in) - **NO**
3. one-time service level or cart(s) adjustment at a new account (move-in) within first 120 days – **NO**<sup>(b)</sup>
4. remove TR, REC, or YW carts from a closed account (move-out) – **NO**<sup>(b)</sup>
5. remove TR, REC, or YW carts from a cancelled account (non-move-out) – **YES**
6. deliver TR, REC, or YW carts to a reactivated account (non-move-in) - **YES**
7. exchange to a larger or smaller size TR or REC cart(s) - **YES**
8. deliver or remove additional TR or REC cart(s) - **YES**
9. resident requested removal of cart(s) before a seasonal/vacation hold – **YES**
10. resident requested delivery of cart(s) after a seasonal/vacation hold – **YES**
11. LRS removal of cart(s) from a residence due to non-payment – **YES**
12. LRS return of cart(s) to a residence after account brought current – **YES**
13. replacement of lost, stolen, or missing TR, REC, or YW cart(s) – **YES**<sup>(c)</sup>
14. replacement of TR, REC, or YW cart(s) damaged by resident– **YES**<sup>(d)</sup>
15. replacement of TR, REC, or YW cart(s) damaged by LRS vehicle – **NO**<sup>(c)</sup>
16. replacement of TR, REC, or YW cart(s) damaged by a third-party vehicle – **YES**<sup>(c)</sup>

Conditions not described above will be mutually decided by the District and Contractor on a case-by-case basis.


Notes:

- a. Abbreviations: TR = Trash, REC = Recycle, YW = subscription Yard Waste
- b. For Items #1, #3, or #4 – the number of carts delivered or removed without cost is not limited to two.
- c. For Items #13, 15, or 16 - resident will not be charged for the replacement cost of the cart(s).
- d. For Item #14 - resident will be charged for the replacement cost of the cart(s) which shall be the current market value of the cart(s), based upon the size and type of cart, and shall not exceed \$50.00 per cart.

Both parties agree this Amendment 2020.5 to the Agreement shall be effective April 1, 2022. All terms and conditions of the Agreement not specifically amended herein shall remain in full force and effect.

**IN WITNESS WHEREOF**, the parties hereto have caused this Amendment 2020.5 to the Agreement for Solid Waste Disposal Services to be executed by their duly authorized representatives.


