# 1. Treasurer's Report

Joe Dragoo presented the Treasurer's report for September 30th. CTSWDD Account Balance was \$15,823.97. Motion to approve treasurer's report was made by Steven and was seconded by Larry. A roll call vote was taken, and the motion passed unanimously.

## 2. Presentation of Outstanding Bills

#### I. Old Business

Steve made a motion approving Larry to sign the amendment as President of the CTSWDD Board. The motion was seconded by Joe. A roll call vote was taken and the motion was passed unanimously.

- 2. We discussed the 2022 calendar year budget. We reviewed the 2021 budget and forecasted spending for 2021. We then asked Steve to update the first pass at the 2022 budget per our discussion and to provide for budgeted funds so that the Board could undertake a study in 2022 on business related solid waste disposal requirements.
